## 4. In-Test Monitoring

During the six minutes, the worksheet may have spaces to record vitals at specific intervals (e.g., every minute or at the end of minute 3). Some clinicians also note any symptoms reported by the patient, such as chest tightness, dizziness, or leg cramps. The number of rests taken and total rest time are also documented, as frequent rests can indicate poor functional capacity.

## 5. Post-Test Data

Immediately after the test, the worksheet captures:

- Total distance walked (calculated from laps and partial laps)
- Post-test heart rate, blood pressure, respiratory rate, and oxygen saturation
- Post-test dyspnea and fatigue scores (Borg scale)
- Any symptoms that occurred during the test
- Reason for early termination if the test was stopped before six minutes

## 6. Interpretation and Comments

Many worksheets include a section for the clinician to record their interpretation, such as comparing the result to predicted normal values for the patient's age, gender, and height. It may also include a space for notes on whether the test was valid and if any modifications were made (e.g., using a walker or oxygen).

### HOW TO USE THE 6 MINUTE WALK TEST WORKSHEET: STEP BY STEP

## Step 1: Prepare the Environment

Some worksheets allow recording of oxygen saturation and heart rate at 1, 3, and 5 minutes. If the patient stops to rest, note the time and duration. If any concerning symptoms arise, stop the test and record the reason on the worksheet.

## Step 5: End the Test and Collect Post-Test Data

At the six-minute mark, instruct the patient to stop. Immediately measure and record post-test vitals. Ask the patient to rate their dyspnea and fatigue again. Calculate the total distance: (number of full laps × 30 meters) + distance of the final partial lap (measure the remaining meters using the marked floor lines). Enter this on the worksheet.

## Step 6: Interpret and File

Compare the walked distance to age- and gender-based reference values. Many worksheets include a predictive equation or a table. Note any clinically significant changes from previous tests. Finally, sign and date the worksheet, and store it in the patient's record.

### INTERPRETING THE RESULTS FROM A 6 MINUTE WALK TEST WORKSHEET

The most straightforward result is the total distance walked in six minutes. However, the **6 Minute Walk Test Worksheet** provides far more context. A change of approximately 30 meters is generally considered the minimal clinically important difference (MCID) for many chronic conditions. Predictive equations exist that account for age, gender, height, and weight. A result below 80% of

the predicted value is often considered abnormal. The worksheet should make space to record the predicted value and the percentage achieved.
