Without passing this exam, you cannot legally work as a nursing assistant in a skilled nursing facility, long-term care center, or similar setting within the state.

The exam consists of two distinct parts: a written or oral knowledge test and a clinical skills demonstration. Both sections must be passed to earn certification. ## The Written or Oral Portion

## The Clinical Skills Demonstration

This hands-on portion requires you to perform between three and six randomly selected nursing skills in front of a registered nurse evaluator. You will be observed for proper technique, safety, and communication with the resident (often played by a mannequin). Common skills include hand washing, measuring blood pressure, making an occupied bed, feeding, transferring a resident, and providing perineal care.

Each skill has a specific set of steps you must follow in order. Even small omissions, such as forgetting to knock before entering a resident's room, can result in a failed attempt. ## BUILDING YOUR STUDY PLAN FROM THE GROUND UP

Creating a structured study schedule is essential. Cramming the night before rarely works for this exam because both the knowledge and the skills require repetition and muscle memory. Below are the key components of an effective study plan.

## Gather the Right Materials

Start with the official Illinois Nurse Aide Candidate Handbook, available through the IDPH website. This handbook outlines exactly what will be tested and how each skill should be performed. Many candidates also use flashcard apps, practice tests, and video demonstrations to reinforce learning.

As you progress, take additional tests to measure improvement. Aim to score at least 80 percent on several consecutive practice tests before scheduling your official exam.

Many online platforms offer practice questions modeled after the actual Illinois exam. Some are free, while others require a small fee. ## MASTERING THE CLINICAL SKILLS: A DEEPER LOOK

## The Most Commonly Tested Skills

While any skill from your training could appear, certain skills are tested more frequently. These include:

- Hand washing (medical aseptic technique)

- Measuring and recording pulse and respiration
- Ambulation with a gait belt
- Transferring a resident from bed to wheelchair
- Providing catheter care
- Performing passive range of motion exercises
- Making an occupied bed
- Providing mouth care

Focus your practice time on these high-frequency skills. However, do not neglect the others entirely. The evaluator may select any skill from the official list of 22 or 23 tasks.

## Communication and Resident Interaction

One area where many candidates lose points is communication. The evaluator expects you to talk to the resident throughout the skill demonstration. Introduce yourself. Explain what you are going to do. Ask for permission. Provide privacy. Encourage the resident to help as much as possible. Always knock before entering and close the door or curtain for privacy.

Even though you are likely working with a mannequin, treat it as a real person. This shows the evaluator that you understand the importance of dignity and respect in nursing home care. ## Infection Control: The Non-Negotiable

Infection control is woven into every single skill. You must wash your hands before and after each task. You must use gloves when there is potential contact with bodily fluids. You must dispose of contaminated materials properly. Forgetting a hand wash step or touching a clean surface with contaminated gloves is a common reason for failure.

Memorize the hand washing procedure exactly as the state requires. It is typically 20 seconds of vigorous rubbing with soap and warm water, covering all surfaces of the hands and fingers. Dry with a paper towel and use that same towel to turn off the faucet. This is one skill you will perform multiple times during the exam, so make it automatic.

### TEST DAY STRATEGIES THAT WORK

---

You have studied hard. You have practiced your skills until they feel second nature. Now it is time to execute. The following strategies will help you stay calm and focused on exam day.

## What to Bring

Bring your photo identification, your scheduling confirmation, and any required paperwork from your training program. Wear comfortable, professional clothing that allows you to move freely. Closed-toe shoes are typically required. Avoid loose jewelry, long nails, or nail polish, as these can interfere with infection control practices.

Arrive at least 30 minutes early. Traffic, parking, or check-in delays can add unnecessary stress. Use the extra time to breathe, review a few notes, and settle your mind.

## During the Written Test

Read each question carefully. Some questions are designed to test your attention to detail. Look for keywords like "always," "never," "except," or "most important." If you are unsure about an answer, eliminate the options that are clearly wrong first. Then choose the best remaining answer. Do not leave any questions blank. There is no penalty for guessing, and you might get lucky.

If you are taking the oral version, listen to each question fully before answering. You can ask the proctor to repeat a question if needed.

## During the Clinical Skills Test

You will be given a skill assignment card that lists the skills you must perform. Read it carefully. If something is unclear, ask the evaluator for clarification before you begin. It is better to ask than to assume.

Perform each skill at a steady, deliberate pace. Do not rush. Talking yourself through the steps out loud can help you stay on track. For example, say, "Now I am going to wash my hands," and then do it. This also shows the evaluator that you know what you are doing.

If you make a mistake, do not freeze. Some errors can be corrected if you catch them early. For instance, if you touch a contaminated surface with a gloved hand, remove the glove, wash your hands, and start that portion again. The evaluator may deduct points, but it is better than continuing with a broken sterile field.

### COMMON MISTAKES AND HOW TO AVOID THEM

---

Knowing what trips up other candidates can help you sidestep the same pitfalls. Here are the most common mistakes people make when taking the nursing home exam in Illinois.

- **Skipping hand hygiene.** This is the number one reason for failure. Wash before and after every skill and any time you change tasks within a skill.
- **Forgetting to identify the resident.** Always check the wristband and call the resident by name. This confirms you are providing care to the right person.
- **Raising the bed to the wrong height.** You should adjust the bed to a comfortable working height to protect your own back. Forgetting this step costs points.
- **Not providing privacy.** Close the curtain, door, or screen. Drape the resident appropriately. This is about dignity and respect.
- **Leaving the resident in an unsafe position.** Always ensure the call light is within reach, the side rails are up (if required), and the bed is in the lowest position after care.
- **Failing to document.** Many skills require you to record vital signs or other observations. Have your paper and pen ready and document immediately after measuring.
