# Suspicious Death Cases

The most common application of forensic entomology is in homicide investigations. For example, if the insect evidence suggests that colonization began three weeks before the body was discovered, investigators can focus their search for witnesses and suspect activity during that specific window.

In a contrasting urban case, police found a body in an apartment with the windows closed and the air conditioning running. The low indoor temperature had slowed decomposition, and the standard decomposition timeline did not apply. Challenges and Limitations: The entomologist was unable to place the scene to measure the actual conditions experienced by the insects, rather than relying on weather station data from across the city.

The larval development rates were analyzed in relation to the measured indoor temperatures, and the entomologist concluded that the body had been there for 10 days, not the 21 days that the neighbor had reported since last seeing the victim. This discrepancy led detectives to re-interview the neighbor, who eventually admitted to witnessing the death and failing to report it. The entomological evidence was critical in revealing the timeline discrepancy.

# Environmental Variability
