Intersecting Lines

Any two lines that cross at a single point are called intersecting lines. This is the most general relationship. Parallel and perpendicular lines are both special cases of this relationship? Actually, parallel lines do not intersect, while perpendicular lines are a specific type of intersecting line. Transversal Lines

A **transversal** is a line that intersects two or more other lines at distinct points. When a transversal cuts through two lines, it creates a set of eight angles. ANGLE PAIRS AND THEIR SPECIAL RELATIONSHIPS

When two or more angles are related by their positions or measures, they form special pairs. Understanding these pairs is a major focus of **Geometry Chapter 1 Lines And Angles**.

Complementary Angles

Two angles are complementary if the sum of their measures is 90° . Each angle is called the complement of the other. For example, a 30° angle and a 60° angle are complementary. They do not have to be adjacent (sharing a common side) to be complementary.

Supplementary Angles

Two angles are supplementary if the sum of their measures is 180° . Each angle is called the supplement of the other. A 110° angle and a 70° angle are supplementary. Again, adjacency is not

Adjacent Angles

Adjacent angles share a common vertex and a common side but do not overlap. They are "next to" each other. Two adjacent angles that form a straight line are a linear pair, and they are always supplementary.

Vertical Angles

Vertical angles are formed when two lines intersect. They are the pairs of opposite angles created by the intersecting lines. The key property is that **vertical angles are always congruent** (they have the same measure). For instance, if two lines intersect and form a 40° angle, the vertical angle directly across from it will also be 40° . This is a fundamental theorem in **Geometry Chapter 1 Lines And Angles**.

Linear Pair

A linear pair is a pair of adjacent angles whose non-common sides are opposite rays. Essentially, they form a straight line. The key theorem here is that the angles in a linear pair are supplementary.
