Submitting a shipment on damaged, non-standard, or unlabeled pallets is a sure way to receive a compliance violation. Invest in high-quality pallets and inspect them before loading. Clean, sturdy pallets reflect positively on your company's attention to detail.

## Missing Appointment

A carrier who arrives two hours late for a 2-hour appointment window may be turned away. Build in buffer time and use GPS tracking with your carriers to ensure they meet their windows. If a delay is inevitable, try to reschedule the appointment as early as possible.
