The protocol is based on your lean body mass (LBM), not your total body weight.

1. **Protein:** 1.5 – 2.0 grams per kilogram of LBM (approximately 0.7 – 0.9 grams per pound of LBM). This is the non-negotiable foundation.
2. **Fat:** As low as possible, typically around 10-20 grams per day. This includes the minute amounts found in lean protein sources.
3. **Carbohydrates:** Less than 20-30

grams per day, coming only from leafy green vegetables and condiments.

4. **Calories:** For a lean individual, this often results in a total caloric intake of 800-1200 calories per day.

## Allowed Foods

- **Low-Calorie Condiments:** Vinegar, mustard, hot sauce, and fat-free salad dressings.
- **Beverages:** Water, black coffee, and unsweetened tea.

- Grains, bread, pasta, rice, and starchy vegetables.
- Fruit (except for a few berries on the free meal).
- Dairy (excluding non-fat cottage cheese and Greek yogurt in small amounts).
- Oils, butter, nuts, seeds, and avocados.
- Most processed foods and sauces.
