Ballistics analysis, toxicology, fire debris analysis, and digital forensics all emerged as specialized disciplines. Today, forensic science continues to evolve with advances in genomics, spectrometry, and artificial intelligence, making investigations more precise than ever before.

# DNA Analysis and Serology

DNA profiling has become the gold standard for human identification in forensic investigations. Every individual, with the exception of identical twins, possesses a unique DNA profile. Forensic scientists analyze biological samples such as blood, saliva, semen, hair roots, and skin cells to generate profiles that can link a suspect to a crime scene or exonerate the innocent. The process involves extracting DNA, amplifying

specific regions using polymerase chain reaction (PCR), and comparing the resulting profile against known samples. The sensitivity of modern DNA tests allows analysis from microscopic samples, including touch DNA left by simply handling an object.

# Fingerpri nt Analysis

Fingerprint analysis is one of the oldest and most reliable forensic disciplines. The ridges on human fingers, palms, and soles form unique patterns that remain unchanged throughout life. Forensic examiners

classify fingerprints into three main types: loops, whorls, and arches. At a crime scene, fingerprints may be visible (formed by blood, ink, or other substances) or latent (invisible deposits of sweat and oil that require chemical or physical development). Common development techniques include dusting with powder, fuming with cyanoacrylate (superglue), and using chemical reagents like ninhydrin or silver nitrate. The comparison process involves analyzing ridge characteristics, called minutiae, to determine whether two prints match.

Firearms examination involves analyzing bullets, cartridge cases, and firearm components to determine whether a particular weapon was used in a crime. When a firearm is discharged, the barrel, firing pin, breech face, and extractor leave unique microscopic marks on the bullet and cartridge case. Forensic examiners use comparison microscopes to match these marks, much like matching two pieces of a broken puzzle. Ballistics experts also

analyze bullet trajectory, muzzle-to-target distance, and shooting reconstruction to understand the dynamics of a shooting incident.

## Toxicology

Forensic toxicology deals with the detection and identification of drugs, poisons, and other chemical substances in biological samples. Toxicologists analyze blood, urine, hair, and tissue specimens to determine whether alcohol, prescription medications, illicit drugs, or poisons contributed to a person's behavior, impairment, or death. This discipline plays a critical role in cases involving driving under

the influence, sexual assault (drug-facilitated), suspicious deaths, and workplace accidents. Gas chromatography-mass spectrometry (GC-MS) and liquid chromatography-tandem mass spectrometry (LC-MS/MS) are among the most commonly used analytical techniques.

## Digital Forensics

In the digital age, electronic devices contain a wealth of evidence. Digital forensics involves the recovery, preservation, and analysis of data from computers, smartphones, tablets, networks, and cloud storage. Investigators can recover deleted files, examine internet

history, analyze metadata, and trace digital communications. This discipline is vital for cases involving cybercrime, fraud, child exploitation, corporate espionage, and terrorism. The fundamental principle of digital forensics is to maintain the integrity of the original data by working on copies and documenting every step of the process.

## Trace Evidence Analysis

Trace evidence encompasses a wide range of microscopic materials that can link a suspect, victim, or location to a crime. Common types include

hair, fibers, glass fragments, paint chips, soil, gunshot residue, and pollen. Forensic scientists analyze these materials using microscopes, spectrometers, and other analytical instruments to determine their composition and origin. For example, comparing a fiber found on a victim's clothing to fibers from a suspect's carpet can establish a connection. Locard's principle is most clearly demonstrated in trace evidence analysis: every contact leaves a trace.

Before any evidence is collected, the scene must be thoroughly documented. This involves three complementary methods:

- **Photography:**  
Photographs capture the

scene exactly as it was found, including overall views, mid-range shots showing relationships between objects, and close-ups of individual evidence items with scales for size reference.

- **Sketching:** A rough sketch shows the dimensions of the scene and the precise location of each piece of evidence. Measurements are taken from fixed reference points, and the sketch is later refined into a finished diagram for court presentation.
- **Note-taking:** Investigators

record detailed notes describing observations, actions taken, evidence collected, and any changes to the scene. These notes serve as the foundation for later reports and testimony.

## Evidence Collection and Preservation

Evidence must be collected in a manner that preserves its integrity and prevents contamination. Different types of evidence require

specific collection methods:

1. **Biological evidence** (blood, saliva, semen) is collected using sterile swabs, allowed to air dry, and stored in paper bags or envelopes to prevent mold growth.
2. **Fingerprints** are developed using appropriate techniques and lifted with adhesive tape or photographed.
3. **Trace evidence** is collected using forceps, tape lifts, or vacuuming, then placed in clean containers.
4. **Firearms and ammunition** are handled carefully to preserve

fingerprints and DNA, then packaged in boxes or gun cases.

5. **Digital devices** are placed in Faraday bags to prevent remote wiping or alteration of data.

Each evidence item must be properly labeled with a unique identifier, description, location, collector's name, and date. The chain of custody documents every transfer of evidence from collection through analysis to court presentation, ensuring that the evidence cannot be tampered with or challenged.

## **LABORATORY**

Once evidence is collected, it is transported to a forensic laboratory for analysis. Laboratories are typically organized into specialized units corresponding to the major forensic disciplines. The results are interpreted and reported in a formal written report that includes the scientist's conclusions and the basis for those conclusions.
