## Why Wells Fargo Puts Emphasis on a Contribution Letter

Wells Fargo, like all major lenders, operates under strict guidelines from investors and government-sponsored enterprises like Fannie Mae and Freddie Mac. These guidelines often require borrowers to demonstrate an ability to pay a modified payment, but they also value a demonstration of "willingness to pay." A contribution letter addresses the willingness aspect directly. If you have the means to make a lump-sum payment or to increase your monthly contribution, it can tip the scales in your favor.

Furthermore, a well-written contribution letter can help you avoid foreclosure. Foreclosure is expensive for banks, and they prefer a modified loan that performs over a non-performing asset. By showing that you can contribute something—even a modest amount—you reduce the bank's perceived risk. This is especially true if your hardship is temporary, such as a medical emergency or a short-term job loss. A contribution letter proves that your financial situation is not entirely hopeless and that you have resources to draw upon.

### **KEY COMPONENTS OF AN EFFECTIVE CONTRIBUTION LETTER FOR WELLS FARGO**

To create a persuasive contribution letter, you must structure it carefully.

Wells Fargo receives thousands of modification requests, so your letter needs to stand out for its clarity, honesty, and professionalism. Below are the essential elements you should include.

## 1. Clear Header and Contact Information

Start with your full name, current address, phone number, email address, and Wells Fargo loan number. This might seem basic, but many applicants forget to include their loan number, which can cause delays. The header should also include the date and the name of the Wells Fargo representative handling your case, if known.

## 2. A Brief Statement of Intent

Open the letter with a straightforward statement that you are requesting a loan modification and that you are submitting this contribution letter as part of your application. Avoid lengthy introductions. For example: "I am writing to formally request a loan modification for my property located at [address]. Enclosed with this letter is my good-faith offer of [amount] to be applied toward my delinquent balance." This direct approach immediately signals your purpose.

### 3. Explanation of Hardship

This is where you explain why you fell behind on your payments. Be honest and specific. Instead of saying "I lost my job," provide details: "I was laid off from my position as a project manager on March 15, 2024, and I was unable to secure new employment until August 2024." If the hardship is medical, mention the illness, the treatment timeline, and the associated costs. The goal is to help Wells Fargo understand that your hardship was beyond your control and that you have taken steps to recover.

### 4. Detailed Financial Overview

You do not need to attach bank statements here, but you should summarize your current financial situation. Include your current monthly income (from all sources), your essential monthly expenses (housing, utilities, food, transportation, medical), and your available assets. This shows the lender that you have a realistic grasp of your finances. It also sets the stage for your contribution offer.

### 5. The Contribution

### Offer

This is the heart of the letter. Clearly state what you are offering to contribute. Be realistic. If you have savings, you might offer a lump-sum payment of \$5,000 or \$10,000. If you do not have a lump sum, you can offer to make three higher payments for the first three months of the modification, or you can propose to sell a secondary vehicle or other non-essential asset and contribute the proceeds. The key is to demonstrate that you are willing to make a sacrifice. For many homeowners, this might mean reducing discretionary spending, using retirement funds (if allowed), or borrowing from family. Whatever you offer, be specific about the amount and the timeline.

### 6. Acknowledgment of Responsibility

Take ownership of the delinquency. Even if your hardship was severe, it is important to acknowledge that you fell behind on your obligations. A simple sentence like, "I understand that I am responsible for the missed payments, and I am committed to resolving this situation," can go a long way in building trust with the underwriter.

### 7. Request for a Specific

Indicate what type of modification you are seeking. Do you need a lower interest rate? A longer repayment term? A principal forbearance? Or a combination? While you may not know all the technical details, expressing a preference shows that you have done your homework. You can say, "I am requesting a modification that will reduce my monthly payment to \$1,500, which is 31% of my current monthly income. I believe this is sustainable for my household."

## 8. Closing and Signature

Close the letter by reiterating your commitment and your hope for a positive outcome. Thank the reviewer for their time and consideration. Sign the letter manually or electronically, and include your printed name below the signature.

### **TIPS FOR WRITING A PERSUASIVE CONTRIBUTION LETTER**

Now that you know the structure, let us look at some strategic tips to make your contribution letter more effective. These insights come from housing counselors and former loan officers who have seen thousands of these letters.

## Be Honest and

## Transparent

Do not exaggerate your hardship or your assets. Wells Fargo will verify the information you provide against your submitted financial documents, tax returns, bank statements, and credit report. If you claim to have no savings but offer a \$10,000 contribution, the underwriter will question the source of those funds. Consistency is key. If you are offering a lump sum, be prepared to show how you obtained the money.

## Keep It Concise but Comprehensive

While the letter should be thorough, it should not be a novel. Aim for one to two pages. Use short paragraphs and bullet points for clarity. Underwriters read hundreds of letters, and a well-organized, easy-to-read document is more likely to be reviewed carefully. Use **bold** to highlight key elements like the contribution amount or the hardship event, but do not overdo it.

## Demonstrate a Change in Circumstances

Lenders want to see that your hardship has passed or is resolving. If you were unemployed but now have a job, emphasize that. If you had a medical emergency but are now recovering, mention that. The contribution offer is

more compelling if it is backed by a stable or improving financial situation. For example: "Since returning to work in September, my income has stabilized, and I can now commit to a modified payment of \$1,200 per month. Additionally, I have set aside \$3,000 from my tax refund to contribute toward my arrears."

## Consider Including a Recalculated Budget

Along with your contribution letter, many successful applicants include a simple budget table showing how they will manage the new payment. This is not always required, but it can be a powerful addition. List your income, essential expenses, and the proposed mortgage payment. Leave a small margin for savings or emergencies. This shows Wells Fargo that you have thought through the sustainability of the modification.

## Use Professional Language

Even if you are upset about your situation, do not let that emotion seep into the letter. Avoid blaming the bank, the economy, or other parties. Maintain a respectful, business-like tone. Use polite phrases like "I respectfully request" and "I appreciate your consideration." Professionalism can set you apart from applicants who submit

emotional or confrontational letters.

### COMMON MISTAKES TO AVOID IN YOUR CONTRIBUTION LETTER

- **Being too vague:** Avoid general statements like "I will try to pay more." Instead, state a concrete amount and timeline.
- **Omitting the loan number:** This is one of the most frequent mistakes. Without it, your letter may be misfiled or delayed.
- **Offering an unrealistic contribution:** Do not offer what you cannot deliver. If you promise a \$5,000 contribution but cannot produce it, the modification may be denied or rescinded.
- **Neglecting to mention willingness to negotiate:** Leave the door open for dialogue. You can say, "I am open to discussing alternative solutions that would work for both parties."
- **Copying a template without personalization:** While templates can be helpful, your letter must reflect your unique situation. Generic letters are easily spotted and may be taken less seriously.

1. **Introduction:** State your name,

3. **Current financial situation:** Summarize your income, expenses, and assets.
4. **Offer of contribution:** Clearly state the amount you are offering and how you obtained it (e.g., savings, sale of an asset, family gift).
5. **Requested modification terms:** Describe what payment you can afford and what type of modification you are seeking.
6. **Commitment statement:** Reaffirm your dedication to keeping the home and honoring the new agreement.
7. **Closing:** Thank the reviewer and provide your contact information.

## HOW A CONTRIBUTION LETTER FITS INTO THE LARGER WELLS

## FARGO LOAN MODIFICATION PROCESS

Submitting a contribution letter is just one step in a multi-stage process. First, you must complete the application packet, which includes proof of income, a hardship affidavit, bank statements, and tax returns. The contribution letter is usually submitted alongside these documents. After submission, Wells Fargo will assign a loan analyst to review your file. The analyst will evaluate your income, debt ratios, and the proposed contribution. If the contribution letter is compelling, it can accelerate the review process and lead to a trial modification plan. During the trial period, you will make reduced payments to demonstrate your ability to maintain the new terms. After three to six months of on-time payments, the modification becomes permanent.
