# Electric Charge and Electric Force

At its heart, electricity begins with charge. Every proton carries a positive charge; every electron carries a negative charge. Electric current ( $I$ ) is the rate at which charge moves through a conductor. It is measured in **amperes**

**(A).** The push that drives this flow is the voltage difference ( $V$ ) between two points. Every material resists the flow to some degree; that property is **resistance ( $R$ )**, measured in ohms ( $\Omega$ ). The relationship between these three is Ohm's law:  $V = IR$ . This simple equation is the workhorse of circuit analysis. A good study guide will encourage you to practice rearranging this formula and solving for any unknown variable.

## Parallel

Circuits are the practical realization of electricity. In a **series circuit**, components are connected end-to-end, so the same current flows through each one. The total resistance is the sum of individual resistances. In a **parallel circuit**, components are connected across the same two points, so the voltage across each is the same, but current divides among the branches. Understanding how to calculate equivalent resistance, current, and voltage in both configurations is a must for any Electricity And Magnetism Study Guide. Practice drawing circuit diagrams and using

Kirchhoff's laws — the junction rule (current in equals current out) and the loop rule (sum of voltage changes around a closed loop is zero).

# Magnets and Magnetic Fields

Magnetism begins with dipoles — every magnet has a north and a south pole. Opposite poles attract; like poles repel. Unlike electric charges, magnetic poles cannot exist in isolation; if you cut a magnet in half, you get two smaller

magnets, each with both poles. Magnetic field lines emerge from the north pole and enter the south pole, forming continuous loops. The strength of a magnetic field is measured in **teslas (T)** or gauss (G). # Moving Charges

This is the critical link to electricity: a moving charge creates a magnetic field. A current-carrying wire produces a circular magnetic field around it, described by the right-hand rule. If you point your thumb in the direction of current, your fingers curl in the direction of the magnetic field lines. This principle is the foundation of electromagnets — coils of wire (solenoids) that concentrate the magnetic field and can be turned on or off with a switch.

# Magnetic Force on Moving Charges and Currents

A charged particle moving through a magnetic field experiences a force perpendicular to both its velocity and the field direction. ## Electromagnetic Induction

Michael Faraday discovered that a changing magnetic field can induce an electric current in a nearby conductor. This is **electromagnetic induction**, the principle behind generators and

Faraday's law states that the induced electromotive force (EMF) equals the negative rate of change of magnetic flux through a loop. Lenz's law tells us that the induced current opposes the change that produced it — a kind of electromagnetic "inertia." Induction explains how a moving magnet near a coil lights up an LED, and how power plants convert mechanical energy into electrical energy.

# Grand Synthesis

James Clerk Maxwell took the known laws — Gauss's law for electricity and magnetism, Faraday's law, and Ampère's law — and added a crucial term (displacement current) to make them consistent. The resulting four equations describe how electric and magnetic fields are generated and how they interact. They predict that light is an electromagnetic wave — a self-propagating oscillation of electric and magnetic fields. This revelation unified optics, electricity, and magnetism into one theory. While a full mathematical treatment is advanced,
