If you have any changes to your legal name, address, or contact information, you must update these details on the

**Ma Hoisting License Renewal Form** and provide supporting documentation such as a marriage certificate or court order.

## HOW TO OBTAIN THE MA HOISTING LICENSE RENEWAL FORM

The official **MA Hoisting License Renewal Form** is available directly from the Massachusetts Department of Public Safety website. You can download it in PDF format. The form is usually titled "Hoisting License Renewal Application" and includes sections for personal information, license class, work history, continuing education, and payment. You will also need to sign and date the form under penalty of perjury.

## STEP-BY-STEP GUIDE TO COMPLETING THE RENEWAL FORM

Filling out the **Ma Hoisting License**

## 1. Personal Information Section

Read the statements on the form carefully. By signing, you confirm that all information is true and correct and that you are not under the influence of drugs or alcohol that could impair your ability

to operate hoisting equipment. Your signature must be original (not digital) if submitting a paper form.

## 7. Payment Information

Indicate your payment method. Fees vary by license class and whether you are renewing on time or late. As of the latest update, renewal fees range from approximately \$50 to \$150 for most classes, with late fees adding an additional \$30-\$50. Include a check or money order payable to the Commonwealth of Massachusetts if mailing. Online renewals may allow credit or debit card payments.

## SUBMISSION OPTIONS: MAIL VS. IN-PERSON VS. ONLINE

---

The **MA Hoisting License Renewal Form** can be submitted through multiple channels. Historically, many operators mailed their forms to the DPS office in Boston or visited regional offices. - **Incorrect fee amount** — Double-check the fee schedule for your

class and any late penalties.

- **Waiting until the last minute** — Submit at least 30 days before expiration to avoid lapses.

## WHAT HAPPENS AFTER SUBMISSION

---

Once the DPS receives your **Ma Hoisting License Renewal Form** and all required documents, they will review your application. Processing times vary but typically range from 2 to 6 weeks for mail submissions. Online renewals may be processed within a few business days. You will receive a new license card valid for two years. If your application is missing information or contains errors, the DPS will notify you by mail or email. You must respond promptly to avoid expiration of your current license. During

processing, you may continue to operate if your license has not yet expired. However, if it expires before renewal is approved, you must stop operating until you receive the new card.

## RENEWING AFTER EXPIRATION: LATE FEES AND REINSTATEMENT

If you miss your renewal deadline, you typically have a grace period of up to 90 days after expiration to submit your **Ma Hoisting License Renewal Form** with a late fee.
