Know how to find the measure of each interior angle in a regular polygon, as well as the measure of each exterior angle (which is $360/n$). These formulas are frequently tested in both multiple-choice and open-ended questions.

CIRCLES: THEOREMS AND FORMULAS

Circles present a unique set of definitions, theorems, and formulas that require dedicated review. Begin with the basic vocabulary: radius, diameter, chord, secant, tangent, central angle, and inscribed angle. Understand that a central angle measures the same number of degrees as its intercepted arc, while an inscribed angle measures half the measure of its intercepted arc. This relationship is one of the most important in circle geometry. Your geometry final study guide should also cover the relationships between chords, secants, and tangents. For instance, when two chords intersect inside a circle, the product of the segments of one chord equals the product of the segments of the other chord. Practice applying these formulas in both straightforward and composite figure problems.

VOLUME

Three-dimensional geometry is a major component of most final exams. You need to be comfortable calculating the surface area and volume of common solids. Your geometry final study guide should include a systematic review of prisms, pyramids, cylinders, cones, and spheres. For each solid, know the formulas for both surface area (total area of all surfaces) and volume (space inside the solid). Pay special attention to the difference between lateral area and total surface area. For a prism, volume is the area of the base multiplied by the height. For a pyramid, volume is one-third of the base area times the height. For a cylinder, volume is $\pi r^2 h$, and for a cone, it is one-third of that. The sphere has its own unique formula: volume is $\frac{4}{3}\pi r^3$, and surface area is $4\pi r^2$. Practice problems that involve composite solids, where you need to combine the volumes or surface areas of multiple shapes. Also, review units of measurement. Always ensure that your answer is in the correct cubic or square units. Being precise with formulas and units can be the difference between a correct answer and a costly mistake.

COORDINATE GEOMETRY AND TRANSFORMATIONS

Coordinate geometry blends algebra with geometric concepts, and it is a favorite topic for exam questions because it tests multiple skills at once. Your study guide should cover the distance formula, the midpoint formula, and the slope formula. These three algebraic tools allow you to find lengths, midpoints, and the orientation of lines in the coordinate plane. Practice using the distance formula to verify that two sides

Being able to perform and describe these transformations is a common requirement on a geometry final.

TRIGONOMETRY ESSENTIALS FOR GEOMETRY

While trigonometry is often a separate course, basic trigonometric concepts are frequently included in a geometry final. The primary focus is on right triangle trigonometry. Your study guide must cover the three basic ratios: sine (opposite/hypotenuse), cosine (adjacent/hypotenuse), and tangent (opposite/adjacent). Memorize the mnemonic SOHCAHTOA to recall these relationships. Practice using these ratios to find missing side lengths and missing angle measures in right triangles. Additionally, understand the relationship between the angle of elevation and the angle of depression, and how to set up trigonometric equations from word problems
