HOLOGRAPHIC WILL

A holographic will is entirely handwritten and signed by the testator, often without witnesses. While a few states recognize holographic wills as valid, they are risky because they may not meet formal legal requirements and are more easily contested. For most people, a typed and properly witnessed

will is far safer and more reliable.

Step-by-Step Guide: How To Write A Will

Legal Requirements for a Valid Will
