supplier to the buyer for goods shipped, referencing the original purchase order and ship notice.

- **Functional Acknowledgment (997):**

A technical receipt confirming that an EDI document was received and was syntactically correct.

- **Inventory Inquiry/Advice (846):**

A report on current inventory levels, often used for vendor-managed inventory programs.

- **Payment Order/Remittance Advice (820):**

Electronic payment instructions and detailed

remittance
information.
