## CALCULATING THE MEAN FOR GROUPED DATA

When data is presented in frequency distribution tables (grouped data), we cannot simply add individual values because we only know intervals. Instead, we use the midpoint of each class interval. The formula becomes:

$$\text{Mean} = (\Sigma (\text{midpoint} \times \text{frequency})) \div (\Sigma \text{frequency})$$

**Example:** A class of 30 students scored as follows:

- Interval 0-10: frequency 4 (midpoint 5)
- Interval 10-20: frequency 8 (midpoint 15)
- Interval 20-30: frequency 12 (midpoint 25)

interval 10-15 frequency 6  
(midpoint 35)

Calculate the sum of (midpoint  $\times$  frequency):

- $5 \times 4 = 20$
- $15 \times 8 = 120$
- $25 \times 12 = 300$
- $35 \times 6 = 210$
- Total =  $20 + 120 + 300 + 210 = 650$

Total frequency =  $4 + 8 + 12 + 6 = 30$ .  
Mean =  $650 \div 30 \approx 21.67$

This mean is an approximation because we assume values within each interval are evenly distributed. For grouped data, the calculated mean is not exact but provides a good estimate.

suitable for ratios.

## Weighted Mean

When some values are more important than others, we use a weighted mean. Each value is multiplied by a weight factor before summing, and then divided by the sum of weights. For instance, if a course has assignments (weight 0.4) and exams (weight 0.6), the weighted mean calculates the overall grade. This is widely used in grading systems and surveys.

temperature is the mean of high and low temperatures over a period.

In each case, the mean provides a simple summary that facilitates comparison. However, users must be cautious about outliers and distribution shapes.
