Your explanation should demonstrate that you understand how these elements work together to control access. You can add value by discussing how this basic structure is used to build complex roles in real-world projects.

roles, on the other hand, inherit authorizations from a master role but allow for modifications. You should discuss when you would use each approach, emphasizing how composite roles reduce administrative overhead while derived roles provide flexibility for specific user groups. Mentioning best practices for role design, such as limiting the use of derived roles to avoid maintenance complexity, will impress your interviewer.

Your response should cover the entire lifecycle. Start by describing how risks are defined using rulesets, which are based on authorization objects and critical combinations of activities. The risk analysis engine checks user roles and direct authorizations against these rulesets. When a risk is identified, the system flags it with a severity level, such as critical, high, medium, or low. The remediation process involves either mitigating the risk through compensating controls, redesigning roles, or implementing

emergency access processes. You can discuss the use of **MSMP** (Multi-Step Multi-Path) workflows for approval and how Deloitte helps clients design these workflows to meet audit requirements. Demonstrating knowledge of real-world risk scenarios, such as segregation of duties conflicts in finance, will strengthen your answer.

Fourth, review the role's authorization data for any missing or incorrect values. You can also mention checking for time-dependent assignments or restrictions in the role. This structured approach demonstrates your analytical rigor and hands-on experience.
