One of the most immersive aspects of the film is its depiction of life in the Dharavi slum, one of Asia's largest informal settlements. Danny Boyle and his crew filmed extensively on location, employing local residents as extras and crew members. The scenes of cramped living quarters, open sewers, and relentless poverty are not exaggerated. For millions of Mumbai residents, this is daily life. The film's authenticity in this regard gives it a documentary-like texture, which fuels the misconception
