Examples include continuous IV medications (e.g., IV diuretics, vasopressors), frequent vital sign monitoring (every 2 hours), telemetry for arrhythmia, oxygen therapy above 2 L/min, or surgical interventions. A well-organized cheat sheet groups interventions by category (medication, monitoring, procedure) for quick scanning.

## 3. Documentation Red Flags

One of the biggest reasons for denial is incomplete or inconsistent documentation. Your cheat sheet should highlight common pitfalls: physicians must explicitly state the medical necessity, not just "admit for observation"; nurses must record exact vital signs and assessment findings; test results should be included in the chart. A simple checklist can save hours of rework.

## 4. Level of Care Distinctions

Interqual differentiates between inpatient, observation, and outpatient care. The cheat sheet should clarify which criteria apply to each level. For instance, some diagnoses (e.g., uncomplicated cellulitis) may qualify for observation if the patient needs IV antibiotics but not inpatient monitoring. 1. **Pre-screen before the full review.** When a new admission or continued stay is flagged, pull out your cheat sheet and quickly check the SI and IS criteria. If the patient obviously meets the main points, proceed with the full documentation. If not, you can address gaps early.
2. **Use it during interdisciplinary rounds.** Keep a digital or printed copy with you while discussing patients with physicians. You can prompt them to document missing criteria: "Dr. Smith, I noticed the patient's oxygen saturation is 88% — could you add that to the note?"
3. **Train new team members.** A

cheat sheet is an excellent training tool. It gives new case managers a scaffold to learn the criteria faster, reducing the learning curve and improving consistency.

4. **Cross-reference with payer-specific guidelines.** Some commercial insurers have their own variations. Your cheat sheet can include a note: "For Medicare, use Interqual version X; for Blue Cross, check additional LOS criteria."

## CREATING YOUR OWN INTERQUAL CHEAT SHEET

---

While many generic templates exist online, the best cheat sheet is tailored to your facility's most common diagnoses, payer mix, and documentation gaps.

Follow these steps to build one that truly works for you.

## Step 1: Identify High-Volume Diagnoses

Pull data from the last six months of your hospital's admissions. Which DRGs appear most frequently? Common ones include heart failure, sepsis, pneumonia, COPD, chest pain, and cellulitis. Focus your cheat sheet on these first, adding others as needed.

## Step 2: Extract Key Criteria from Interqual

Using the official Interqual manual or software, copy the specific SI and IS criteria for each diagnosis. Use bullet points, not paragraphs. Example for chest pain:

- SI: Elevated troponin, ST-segment changes, hemodynamic instability
- IS: Continuous telemetry, IV nitroglycerin, heparin infusion

Keep it short — your goal is a quick scan, not a textbook.

## Step 3: Add Documentation Tips

For each diagnosis, note what the physician must document. For sepsis: "Document lactate > 2 mmol/L, administration of IV antibiotics within 1 hour, vasopressor use if MAP < 65." For heart failure: "Document weight gain, bilateral crackles, ejection fraction if known."

## Step 4: Include Denial Prevention Hacks

Based on your facility's denial trends, add a small section like "Watch Out For:" For example, "Do not admit cellulitis if no signs of systemic infection (fever, leukocytosis) and patient can tolerate oral antibiotics."

Use tables, color coding, or bold headings. Keep font size readable but compact. Print on one double-sided page or save as a PDF for mobile devices. Update your cheat sheet every time Interqual releases new criteria (typically quarterly).
