While their screen time is relatively short, the impact of Si and Am is

immense, making them arguably the most discussed of the **Lady and the Tramp characters Siamese cats** in critical circles.

Understanding the lasting impression of the **Lady and the Tramp characters**

The music itself, with its pentatonic scale and gong-like percussion, was intended to evoke a "mysterious Orient" trope that was common in Western media at the time. For

decades, these characters were seen simply as funny villains, but modern audiences and critics have rightly re-evaluated them as a prime example of harmful stereotyping in classic animation.

## The Controversial Legacy in the Modern Era

In recent years, the conversation around the **Lady and the Tramp characters Siamese cats** has

intensified, leading to concrete action from The Walt Disney Company. As society has become more aware of racial sensitivity and the impact of representation in media, these characters have been placed under a brighter spotlight. The most significant change came with the 2019 live-action/CGI hybrid remake of *Lady and the Tramp*, released on Disney+.

For the remake, Disney made the deliberate decision to completely replace Si and Am. Instead of the scheming Siamese twins, the new film features a single, scrappy stray cat named **Dexter**, a tabby with no connection to the original stereotypes.

The song is a perfect storm of musical exoticism that, while effective as a villain's theme, is deeply rooted in Orientalist tropes. In the 2019 remake, a new song for the cat character, Dexter, was composed to avoid these pitfalls, but the original tune remains a controversial piece of Disney music history. It is rarely performed in official merchandise or stage adaptations, and it is often skipped by modern viewers.
