# What Is the Texas Secretary of State Business Search?

The **Secretary of State of Texas Business Search** is an online database that houses official records for all business entities registered to operate in Texas. This includes corporations, limited liability companies (LLCs), limited partnerships (LPs), limited liability partnerships (LLPs), professional associations, and other statutory entities. The database is maintained by

the Business and Public Filings Division of the Texas Secretary of State.

The primary purpose of this tool is to provide public access to corporate filings, including certificates of formation, annual reports, registered agent information, and any amendments or dissolutions. Anyone can use the database to look up a business by name, file number, or even by the name of an officer or director in some cases. This transparency is vital for fostering a healthy business environment in Texas.

The search tool operates on the **SOSDirect** system, an online portal that allows users to perform searches, order certified documents, and even file new business documents. The system indexes every active and inactive business entity. When you enter search criteria, the system returns a list of matching records, each with links to detailed filing histories and current statuses.

The information you can typically view includes the entity's legal name, file number, formation date, status (e.g., "In Existence," "Voluntarily Dissolved," "Forfeited Existence"), registered agent name and address, and the principal

office address. For publicly traded corporations, additional details may appear. Understanding these fields is crucial for interpreting the results correctly.

## Accessing the SOSDirect System

To begin your **Texas business name search**, navigate to the official website of the Texas Secretary of State. From the

homepage, look for the “Business Filings & Searches” section. There, you will find a direct link to the “SOSDirect” portal. The system is designed to be intuitive, but first-time users may want to read the briefly provided instructions before diving in.

## Search Options: Name, File Number, and More

On the search page, you have several options. The most common is the **business name search**. You can enter

the full or partial name of the entity. The system allows wildcards (using the asterisk \* symbol) to broaden your search. For example, searching “Tex\* Corp” might return all entities starting with “Tex” and containing “Corp.”

## Free vs. Paid Searches

Basic searches on SOSDirect are **free**. You can view the list of matching entities and their statuses without paying a fee. However, if you need to view the actual filed documents (like the Certificate of Formation) or obtain a certified copy of a document, there is a small charge per page or per certificate. The pricing is clearly displayed before you confirm the order. For routine name availability checks, the free search is entirely sufficient.

# Interpreting Search Results

Once you click “Search,” a list of matching names appears. Each entry shows the **entity name, status, file number, and formation date**. Click on a result to see the full detail page. Here, you can see the registered agent’s name and address, the principal office address, and a list of filings associated with the entity. The “Status” field is particularly important: “In Existence” means the business is active and compliant (or at least has not been involuntarily terminated). “Voluntarily Dissolved” means the company chose to close. “Forfeited Existence” often indicates a

failure to file annual reports or pay taxes.

Always carefully note the entity suffix (LLC, Inc., Ltd., etc.) to ensure you are looking at the correct business. Many similar names exist, especially with popular words like “Texas” or “Lone Star.”

# Verify Business Legitimacy

Before entering into a contract or making a large purchase, it is prudent to confirm that the business you are

dealing with is legally authorized to transact in Texas. A quick **Secretary of State of Texas Business Search** can reveal whether a company is still in good standing. If the status shows “Forfeited Existence” or “Involuntary Dissolution,” that company may not have the legal capacity to conduct business, which could void any agreements you sign.

## Check Name Availability

If you are forming a new LLC or corporation, you must choose a name that is not already in use by another entity. The Texas Secretary of State requires that each business name be distinguishable from all other names on

file. Performing a thorough **business entity search** before filing your formation documents will save you the hassle of rejection and potential rebranding.

If a company fails to file, its status becomes “Forfeited Existence.” Checking the status of a potential partner or supplier can help you avoid working with a company that is not in good standing, which could indicate financial trouble or mismanagement.

# LLC, Corporation, LP, LLP, and More

Texas recognizes several business entity types, each with its own characteristics. Understanding these can help you interpret search results more effectively. The most common include:

- **Limited Liability Company (LLC):** Flexible structure with pass-through taxation and limited liability for members.

## TYPES OF BUSINESS ENTITIES IN TEXAS

- **Corporation (C Corp.):** A traditional entity with shareholders, directors, and officers; subject to double taxation unless an S-Corp election is made.
- **Limited Partnership (LP):** Has both general partners (with unlimited liability) and limited partners (liability limited to investment).
- **Limited Liability Partnership (LLP):** Often used by professional services firms (lawyers, accountants); partners have limited liability.
- **Professional Association (PA):** For licensed professionals like doctors and dentists.
- **Nonprofit Corporation:** Organized for charitable,

educational, or religious purposes.

When searching, ensure you use the correct legal suffix. For instance, “Acme LLC” and “Acme Inc.” are considered different entities and will appear separately.

## Search Implications by Entity Type

The search tool treats all entity types equally, but the information shown may vary slightly. For example, a corporation’s detail page often lists its directors, whereas an LLC page lists its organizers and managers. Knowing the

structure helps you know what to expect.

### **TIPS FOR EFFECTIVE SEARCHING**

## Use Exact Names and Wildcards

If you know the exact business name (including punctuation like “&” or “Co.”), enter it precisely. If not, use partial names combined with a wildcard. For example, searching “Bluebonnet\*” will return all entities starting with “Bluebonnet.” However, be careful not to make the search too broad—thousands of results may be overwhelming.

# Understanding Entity Statuses

Common statuses include:

- **In Existence:** The entity is active and has complied with all filing requirements.
- **Voluntarily Dissolved:** The entity has filed for dissolution and is closed.
- **Forfeited Existence:** The entity has been dissolved by the state for failing to file reports or pay taxes.
- **Involuntarily Dissolved:** Similar to forfeited, often used for administrative dissolution.
- **Terminated:** Final dissolution

completed.

Knowing the difference helps you determine whether the entity can still conduct business.

## Avoiding Common Mistakes

One frequent error is not including the entity suffix. For example, searching “Lone Star Consulting” might miss the one named “Lone Star Consulting LLC.” Another mistake is confusing the Secretary of State database with the Texas Comptroller’s tax database—they serve different purposes. The SOS

database shows legal structure, not tax status. Also, remember that the database does not include sole proprietorships or general partnerships (unless they register an assumed name with the county).
