### HOW TO GET YOUR RESIDENCY LETTER NOTARIZED

## Finding a Notary Public

## The Process

The notary will confirm your identity, ask if you are signing voluntarily, and then watch you sign the letter. They will then complete the notarial certificate (the "notary block"), apply their official stamp or seal, and sign the document. The document is now legally notarized. You should make copies for your records and for any requesting institution.

### COMMON MISTAKES TO AVOID
